1. All cattle must be futurity eligible.
2. All cattle must be TLBAA or ITLA registered.
3. All entries must be paid in full by the due date.
4. No change or substitutions of cattle once entered.
5. Cattle blood tested on a random basis.
6. A non-refundable fee of \$250.00 must accompany all protests.
7. Decisions of the judges will be final.
8. The Millennium Futurity Partners are not responsible for accidents to any persons or animals while at the event.
9. Anyone who is proven to have cheated on genetics or age will be banned for life from the Millennium Futurity or any of its events.

The total amount of the entry fee is \$300.00. A nomination fee of \$150.00 is due on or before February 15, 2012. A final payment of \$150.00 is due on or before April 15, 2012. For animals nominated after February 15, 2012, a late fee of \$100 will be applied. Absolutely no entries will be accepted after April 15, 2012.
